CASE SUMMARIES

Case 839: This case documents the discovery of a bird later thought to be an Arctic Warbler *Phylloscopus borealis* found mauled by a cat in Arncliffe, Sydney on June 29, 2011. It was taken to a local veterinary clinic where it subsequently died but it later transpired that a video was taken of the bird and this video recording formed the basis for the submission. Although the overall consensus was that the bird was an Arctic Warbler of undetermined race, two members of the committee felt that the report could not be accepted due to the doubt over the bird's provenance, the location and time of year, and the peculiar circumstances of the event. The committee therefore voted for non-acceptance of the record.

Case 876: This case concerned the sighting of a South Island Oystercatcher *Haematopus finschi* at Shark Island and at other locations in Sydney Harbour from March 1, 2015 until the last report on April 21, 2015. The photographs and description left no doubt as to the bird's identity and the committee voted unanimously in favour of acceptance. It becomes the 9th confirmed record for Australia. Case 884: This case concerned the sighting of a White-rumped Sandpiper *Calidris fuscicollis* initially at Shoalhaven Heads and then at Lake Wollumboola from January 5, 2015 until at least March 19, 2015. The description and superb photographs left no doubt as to the bird's identity and the committee voted unanimously in favour of acceptance.
